Language: English

Referencing Style: APA (7th edition)

- Font: Times New Roman, size 12
- Line Spacing: 1.5
- Margins: 2.54 cm (1 inch) on all sides
- File Format. Microsoft Word (.docx)

#### Structure: Each chapter should typically include:

- Title
- Author(s) full name, institutional affiliation, and contact information
- Abstract (150–200 words)
- 5–7 keywords
- Introduction
- Literature Review / Theoretical Background
- Methodology (for empirical chapters)
- Findings / Discussion
- Implications / Recommendations
- Conclusion
- References
